Females of all breeds of Sheep and Goats (except Dorset Horn, Polled Dorset and Finnish Landrace) to be entered and/or exhibited are:

- i. Non-Pregnant (empty)
- ii. Have not lambed/kidded within 30 days prior to the show
- iii. Are not subject to procedures which change the seasonal breeding pattern

MAEDI VISNA ACCREDITED SHEEP

Maedi Visna accredited sheep exhibitors must ensure they have a Health Status Report which is valid for the date of the show – a completed copy of this MUST accompany their sheep on show day. Sheep MUST NOT be unloaded without a valid Health Status Report.

GOATS

CAE Accredited Goats must have a current CAE certificate, a copy of which should accompany the entry form.
